**WHEREAS:**

**UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal** is involved in providing Technical Education in the field of engineering by acting as a facilitator in the concerned area of expertise.

They are keen to collaborate with a view to utilizing their knowledge and expertise to improving and upgrading institutes/organizations.

**A. Govt. ITI, Dhenkanal** is keen for skill development of youth in high-end technological areas for respectable job / self-employment by way of upgrading ITI campus and workshops with state-of-the-art infrastructure, re-skilling & up-skilling of trainers in all trades and skills to impart advanced level training to trainees of all trades and has agreed in principle to collaborate with the 2nd Party for all round improvement of Govt. ITI, Dhenkanal, under his administrative control.

**B. UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal and Govt. ITI, Dhenkanal** have agreed to collaborate to upgrade and improve the campus and workshop infrastructure of **Government ITI, Dhenkanal** for re-skilling and up-skilling the Trainers to contemporary industry requirement and to expose the students to latest technologies and relevant skill set with an objective to make them industry ready in accordance with the present MoU signed by both the parties

- Now, therefore, **UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal and Govt. ITI, Dhenkanal** agree as follows:

**1. The Project Objective:**

For **UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal** to act as knowledge partner covering all related fields to re-skill and up-skill trainers and trainees of Govt. ITI Dhenkanal and provide services for up-gradng campus and workshop infrastructure

The idea is to provide futuristic facilities to the trainees to practice on, so that they can compete with the best in the world.

**2. Scope of MoU**

**A. Knowledge Partner:**

- A1.** Application of technology to skilling with a view to improving quality.
- A2.** Safety gears, safety parameters & Procedures.
- A3.** Technical knowledge & methodology up-gradation of instructors from time to time.
- A4.** Periodical visit & interaction of ITI trainees in small groups to **UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal** with a view to widening exposure and broadening knowledge.
- A5.** Workshop machinery/tools up- gradation.

**3. Implementation:**

- 3.1. It would be an open-ended MoU and would not be restrictive
- 3.2. Team of experts from both parties will re-visit the MoU from time to time as per the needs of industry and ITI.

**4. Role and Responsibility**

**4.1. Responsibility of Govt. ITI, Dhenkanal:**

4.1.1. Government ITI Dhenkanal will facilitate and coordinate for the ToT, Visit of Trainees & trainers, guest faculty etc.

4.1.2. The Government ITI Dhenkanal shall provide the required physical infrastructure (like buildings classrooms, workshop, etc.) for the re-skilling, up-skilling of trainees & trainers.

**4.2. Responsibilities of UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal:**

4.2.1. **UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal** will allow the trainees & trainers of Govt. ITI Dhenkanal to visit their Lab, Workshops, High end machinery etc. as per their convenience.

4.2.2. If required, **M UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal** may provide infrastructural & intellectual support, wherever feasible, for the effective implementation of the MoU.

**5. Publicity:**

**Both parties** shall have the right to publicize the activities and their respective roles as applicable for the purpose of branding.

**6. Nullity**

**UAL Odisha, A Unit of UAL Industries Ltd, Dhenkanal** and **Govt. ITI, Dhenkanal** agree that the mutually-accepted nullity of any of the provisions of this agreement shall not cause the agreement to be null and void and shall not affect the validity of the other provisions.

**7. Term**


This MoU shall remain in force for 3 years from the date of signing this MoU, unless terminated earlier in accordance herewith. The MoU may be extended if desired on mutual written consent.

**8. Termination**


This MoU may be terminated in whole or in part by any party by giving appropriate reason. However, dispute resolution could be done in case of Non-agreement between both the parties.


